<p>LTIS/RAA Drop-ins (Mohammad)</p>	<ul style="list-style-type: none"> <li>Weekly Zoom drop-ins for teaching staff</li> </ul> <p>Zoom drop-ins for teaching staff start this week with Learning &amp; Teaching Connect and Ranga Auaha Ako team members.</p> <p>These sessions are for questions about learning or assessment design I your course or for technical questions on using Canvas, Panopto, Lecture Recordings, Turnitin, H5P, Perusall, Talis etc. We will run these sessions until the mid-semester break in April as a pilot.</p> <p>Available times for Zoom drop-in: Tuesdays: 2 pm – 3 pm Thursdays: 11 am – 12 pm</p> <p>If you need to raise a support case or request Canvas access, please log a request <a href="#">here</a>.</p> <p>Instructure also offers 24x7 support for Canvas via live chat or phone 0800 005 205</p> <p>All L&amp;T related events and drop-ins are listed on the <a href="#">TeachWell calendar</a>.</p>
<p>Canvas training (Chun)</p>	<ul style="list-style-type: none"> <li>The Canvas Drop-in sessions opened to all staff and have been extended for another two weeks, covering the first two weeks of Semester one.</li> </ul> <p>Top three questions asked in the Canvas drop-ins:</p> <ol style="list-style-type: none"> <li>1. Course Access Coordinators (CAC) cannot edit or add content. But CACs can add people, including themselves, as teachers then edit content in their Canvas courses.</li> <li>2. Make sure assignments are created in Canvas and the weights of assignment groups are set up correctly.</li> <li>3. You can use the link validator tool in Canvas to check all the hyperlinks in your Canvas course. It's important to make sure all the link are working especially when content is imported from another course.</li> </ol>

<p>New Canvas Baseline (Steve)</p>	<ul style="list-style-type: none"> <li>• Context for the 2016 migration to Canvas <p>Decommissioned a local Moodle installation &amp; the bespoke, Cecil platform.</p> <p>Some of the drivers for this change: Risk, BCP, Adopt SaaS technology, and swap CAPEX costs to OPEX.</p> <p>The migration was a classic 'technical lift and shift' (ie, cut &amp; paste).</p> <p>'Canvas Minimum Presence' document identified the expected baseline usage.</p> <p><u>Canvas Minimum Presence:</u></p> <p>Course Syllabus  Copyright material listed in Talis  Course resources available electronically  Grade management via Gradebook</p> </li> <li>• Learner experience in Canvas (2016 -2020) <p>Used Canvas as a digital repository  Inconsistent approaches within degree programmes  Lack of awareness of the pedagogical affordances &amp; importance of the learner experience in the online space.</p> <p>Students experienced inconsistency during their studies, as reflected in multiple L&amp;T feedback surveys and SETs. This is not a unique UoA issue as identified in a recent JISC survey.</p> </li> <li>• Drivers for this update <p>UoA student feedback, international research, and good practice from peer institutions.</p> <p>Aligning the use of Canvas with the strategic goals of Taumata Teitei &amp; the Curriculum Transformation Framework project.</p> </li> </ul>

	<p>Ensuring we meet the accessibility requirements identified in the new UoA disability Action Plan.</p> <ul style="list-style-type: none"><li>• Accessibility</li></ul> <p>In 2021, the Tertiary Education Commission (TEC) moved to recognise accessibility as a 'responsibility' of tertiary education organisations through requiring a Disability Action Plan (DAP).</p> <p>UoA now has a DAP and a programme of work that will address accessibility gaps in Canvas and develop minimum requirements for digital content, based upon principles of Universal Design for Learning (UDL) and Web Content Accessibility Guidelines (WCAG).</p> <p>UoA is licensing UDOIT Advantage for Canvas to support this new requirement.</p> <ul style="list-style-type: none"><li>• Canvas baseline practices</li></ul> <p>Intended to provide students with more consistent, easy to use, and inclusive online learning experiences within their programmes.</p> <p>It is underpinned by Universal Design for Learning accessibility requirements and informed by the student voice.</p> <p>The biggest change involves the intentional use of Canvas' inbuilt features to support a more coherent course structure. With the added opportunity to adopt an academic-driven, consensus approach within a programme, major, or specialisation.</p> <p>The aim is for consistency, not uniformity, in design.</p> <p>Steve gave an overview of the Canvas course design, including the expected baseline practice and the benefits.
