INDONESIA FORUM: AN OVERVIEW

The University of Melbourne pioneered Indonesian studies in the mid-1950s. Over the decades Indonesian studies at the university have seen a growth in student numbers, staffing and the diversity of Indonesia-related subjects offered to students. Research and teaching relating to Indonesia is conducted across several Departments, Faculties and Centres, including Architecture, Arts, Building and Planning, Economics and Commerce, Law and Medicine.

Formed in 1991, the Indonesia Forum, originally known as the Indonesia Interest Group, is an informal and open network of academics and administrative staff at the University who share a common interest and professional involvement in Indonesia. Members keep in touch by email and hold regular meetings, seminars and discussions. For the past eighteen years the Indonesia Forum has hosted major functions that have brought together the wider Melbourne Indonesian and Indonesia-interested community on campus.

The Indonesia Forum also plays a policy advisory role on Indonesia-related issues within the University and works closely with the Asia Institute and Asialink, whose missions are related but more broadly oriented towards Asia as a whole. The Forum also maintains close links with the Indonesian Postgraduate Students Association, international students from Indonesia and domestic students studying in Indonesia-related areas. Since 1999 the Indonesia Forum has convened six-monthly postgraduate roundtables for students studying in Indonesia-related fields. The Indonesia Forum maintains an email bulletin, moderated by Charles A Coppel, to keep members up to date with Indonesia-related events on campus and elsewhere, including in Indonesia. Its website <www.indonesiaforum.unimelb. edu.au> provides Indonesia-related information for staff, students, prospective students and colleagues from other institutions.

CONVENOR'S REPORT 2009

During the year 2009, the Indonesia Forum and its members across different Faculties continued to hold a range of events that attracted good numbers. Its members also produced a range of publications and were successful in attracting new research grants.

The Forum's main event in 2009 was a public lecture on 18 August, which was co-sponsored by the Asian Law Centre. Arskal Salim, a graduate of the Asian Law Centre and Postdoctoral Fellow at the Max Planck Institute for Social Anthropology, Germany, provided an update on politics and Islamisation in Aceh. The lecture and Indonesian dinner that followed it were attended by about 120 people and were part of the Asia Institute's Asia Week program. Asia Week also profiled a number of other Indonesia-related events, including music at the opening ceremony by Fine Blue Thread, a group which fuses Indian and Indonesian musical styles. The Asia Institute also worked with the Indonesian Film Festival, holding the short film competition awards and a talk by a young Indonesian film director as part of Asia Week. The Forum held two Postgraduate Roundtables in 2009, which continued to prove very popular. The 20th Roundtable was held on 9 May and attended by 30 people, with 14 students presenting. Meanwhile, the 21st Roundtable on 17 October was attended by 36, with 12 students presenting.

In addition, on 20 May the Indonesia Forum co-sponsored a seminar with the Nossal Institute for Global Health. Professor Laksono Trisnantoro, the Director of the Centre for Health Service Management at the School of Medicine, Gadjah Mada University, spoke on 'Decentralisation of the Health Sector in Indonesia: Experience from 2000-2007'. On 21 October, Forum members joined a roundtable discussion organised by Asialink, during which members had the opportunity to exchange views with the recently-appointed Indonesian Ambassador to Australia, His Excellency Mr Primo Alui Joelianto.

There were many other events on campus which had Indonesian speakers or an Indonesia focus. The Asian Law Centre (ALC) and Centre for Islamic Law and Society (CILS) sponsored a number of speakers from Indonesia. These included Professor Jimly Asshiddigie, Chief Justice of Indonesia's Constitutional Court, in March, Mr Usman Hamid, Director of KontraS (Committee for Missing Persons and Victims of Violence) in May, and Ms 'Ciciek' Farha Abdul Kadir Assegaf, activist, researcher and consultant on issues concerning gender and Islam. In August, the Indonesia Program of the Asia Institute sponsored a talk by Ms Vivi Widyawati, from Jaringan Nasional Perempuan Mardhika (National Network for Women's Liberation) and member of the PRD (People's Democratic Party). Dr Hari Wibisono from Gadjah Mada University, Yogyakarta, also delivered a research seminar in September, during his time as a Visiting Scholar to the Faculty of Architecture, Building and Planning.



A number of departments and faculties were also involved in organising conferences over 2009. The Faculty of Architecture, Building and Planning organised a public symposium, 'Southeast Asian Urbanism' in June. Also in June, Kate McGregor and Vannessa Hearman from the School of Historical Studies, together with staff from the National University of Singapore, convened an international conference in Singapore on the 1965-1966 killings in Indonesia. The Centre for Islamic Law and Society and the National Centre for Excellence in Islamic Studies organised their annual postgraduate conference in November.

In addition, the Faculty of Architecture, Building and Planning hosted a group of 32 architecture, landscape and planning academics from Bandung Institute of Technology in July, and the Asia Institute coordinated a short course for twenty academics from a range of different Islamic tertiary institutions across Indonesia to build their capacity in research and administration. For a full list of events please see the Highlights section of this report.

As in previous years, Indonesia Forum members managed to maintain a healthy publication rate. Publications included a co-authored book by Howard Dick, a book by Peter Verhezen (both from the Department of Management and Marketing), a co-edited book by Sander Adelaar (Asia Institute), as well as various journal articles, book chapters and newspaper articles by these and other members. Forum members obtained Australian Research Council grants in the 2009 round. Tim Lindsey and Pip Nicholson (Law School) were awarded a Discovery grant for their project 'Drugs, Law and Criminal Procedure in Southeast Asia: A Comparative Analysis', and Thomas Reuter (Asia Institute) was awarded a Future Fellowship for his project 'Religion and Spirituality in the Contemporary World: An Indonesian Case Study'. Across the university a number of Indonesianists still hold ARC Grants won in earlier rounds.

Forum members wish to congratulate Charles Coppel, principal fellow in the School of Historical Studies who, together with Dr Mely Tan and Ms Myra Sidharta, was awarded the 2009 NABIL award for his contribution to Indonesian Nation Building.

Indonesian language enrolments showed another small increase from 2008 to 2009, with enrolment in the University's Indonesian language program standing at 89 students in 2009. The Indonesian language program, together with all other languages taught in the Faculty of Arts, has begun an extensive process of curriculum reform. Based on recommendations from Georgetown University curriculum expert Professor Heidi Byrnes, a reinvigorated integrated curriculum that promotes the simultaneous acquisition of language and literary-cultural content will be developed over the next three to four years.

In 2009 the Indonesia Program gained one full-time staff member, boosting numbers to 2.5, although only 1.5 are continuing positions.



As mentioned in last year's Annual Report, we were sad to farewell Howard Dick and Sander Adelaar in 2008. However, we are delighted that they, together with Arief Budiman, who retired in 2007, are continuing at the university as Honorary Fellows, and we look forward to their continued involvement with the Indonesia Forum, to which they have all made very valuable contributions.

The Indonesia Forum would not have been able to engage in its activities without the help of many other organisations and supporters at Melbourne University. The Forum is very grateful to the Deputy Vice-Chancellors for Global Relations: John Dewar (first half of 2009) and Susan Elliott (second half of 2009), whose Office has guaranteed funding to the Forum for the next three years, enabling more long-term planning. The Faculty of Music and the Asian Law Centre have also provided venues for various functions of the Forum.

As the 2009 Convenor, I am grateful to Charles Coppel, Michael Ewing, Kate McGregor and Elisabeth Riharti for the invaluable work they have put into organising Indonesia Forum events and for their advice and guidance. Charles Coppel has continued to moderate the Indonesia Forum's email listing, which is a vital means of communication both between Indonesia Forum members and with the wider community; and Michael Ewing has maintained the Forum's website. I would like to give special thanks to Dina Afrianty, who organised the 2009 Postgraduate Roundtables and Kelly de Hond, Vannessa Hearman and Nina Lim, for their assistance with the various events held in 2009. The Forum also benefited greatly from the support it received from Tim

Lindsey, Kathryn Taylor, Kelly McDermott, Tom Bray and Tessa Shaw at the Asian Law Centre. Thank you to Cheryl Carter of the Asia Institute for maintaining the accounts of the Forum. Finally, my thanks to Jessica Melvin for all her work in compiling this report and to Tim Lindsey, who took on the role of Deputy Convenor of the Indonesia Forum this year, despite his many other commitments.

HIGHLIGHTS OF 2009

11 March	The Asian Law Centre hosted a Seabrook Chambers Lecture with a presentation by Professor Jimly Asshiddiqie (Chief Justice of Indonesia's Constitutional Court), entitled 'Creating a Constitutional Court for a New Democracy'.
13 March	The Asian Law Centre and Centre for Comparative Constitutional Studies hosted a seminar on the topic of 'Transnational Judging: A Judicial Conversation on Foreign and International Law in Domestic Courts' with presentations by Professor Jimly Asshiddiqie, Chief Justice Black (Federal Court of Australia), Chief Justice French (High Court of Australia), Justice Hayne (High Court of Australia), Justice Vickery (Supreme Court of Victoria) and Justice Weinberg (Court of Appeal of Victoria).
18 March	The Asia Institute presented an evening of gamelan music and masked dance in the style of Cirebon, West Java as part of the University of Melbourne's Diversity Week. Performed by Putra Panji Asmara, with Michael Ewing as director and dancer. The Faculty of Music supported the event through use of instruments and performance space.
10 June	The Asian Law Centre hosted a Brown Bag Seminar with a presentation by Mr Usman Hamid (Director of KontraS -Committee for Missing Persons and Victims of Violence Jakarta) entitled 'Justice for Munir'.
4 June	The Faculty of Architecture, Building and Planning held an public symposium on 'SEA Urbanism', at which some Indonesian material was presented, organised by current and former PhD students, including Eka Permanasari and Wing Raharjo.
4-5 June	The Asian Economics Centre held an Australasian Development Economics Workshop, bringing together development economists from around Australia, New Zealand and all over the world. The workshop began with an opening address by AusAID's chief economist Dr Mark McGillivray. Professor Mark Rosenzweig (Yale University) then presented the keynote lecture on the topic of 'Traditional Institutions, Economic Development, and Economic Growth: New Perspectives on Caste in India'. The workshop was funded by AusAID and this year received supplementary funding from the Asia Economics Centre and the Confucius Centre.



17- 19 June	School of Historical Studies staff, Kate McGregor and Vannessa Hearman, together with colleagues from the National University of Singapore, Professor Anthony Reid and Dr Douglas Kammen, convened an international conference entitled 'The 1965-1966 Indonesian Killings Revisited'. The conference, held in Singapore, gathered scholars from around the world and those working in advocacy and research in Indonesia, as well as the head of the Indonesian Human Rights Commission (Komnas HAM) team investigating the 1965-66 killings, Mr Nurcholis. The conference examined the regional dynamics and lasting effects of the mass killings in Indonesia in 1965-1966. The conference was funded by the Asia Research Institute and the Faculty of Arts and Social Sciences at the National University of Singapore and the Asia Pacific Futures Research Network (APFRN) of the Australian Research Council (ARC).
23- 25 July	The Faculty of Architecture, Building and Planning hosted a group of 32 architecture, landscape and planning academics from the Bandung Institute of Technology, convened by Professor Kim Dovey.
17 August	The Asia Institute, as part of Asia Week, hosted the Indonesian Film Festival's Short Film Competition.
17 August	The Indonesian Program, in cooperation with the Indonesian Film Festival, presented "In Conversation with the Mo Brothers", in which Indonesian Film Directors Mochammad Maliki Stambo and Timo Tjahjanto discussed their work with Tito Ambyo of ABC Radio.
18 August	The Indonesia Forum, in conjunction with the Asian Law Centre, convened a public talk with a presentation by Dr Arskal Salim on the topic of 'Politics and Islamisation in Aceh: An Update'.
19 August	The Asia Institute hosted a Forum on Endangered Languages, focusing on Asia, including languages of Indonesia.



19- 20 August	The Indonesian Program invited Ms Vivi Widyawati, national coordinator of the Jaringan Nasional Perempuan Mahardika (National Network for Women's Liberation) and a leader of the Committee of the Politics of the Poor – People's Democratic Party (KPRM-PRD) to give talks to language students (open to the general public) on issues of women's rights in Indonesia.
26 August	The Centre for Islamic Law and Society presented a Research Seminar with a presentation by Ms 'Ciciek' Farha Abdul Kadir Assegaf on the topic of 'Muslim Women in Radical Islamist Circles: The Case of Al-Mukmin Pesantren, Ngruki'.
21- 25 September	Dr Hari Wibisono, Head of Architecture, Gaja Mada University, Yogyakarta, became a Visiting Scholar to the Faculty of Architecture, Building and Planning, where he delivered a research seminar and engaged in a number of meetings.
22 October	School of Historical Studies principal fellow, Charles Coppel, together with Indonesian scholars Ms Myra Sidharta and Dr Mely G Tan, was presented by the NABIL Foundation with the 2009 NABIL Award for his contribution to the Indonesian Nation Building process. The event was held at the Hotel Mulia, Senayan, Jakarta and received considerable media coverage in Indonesia.
23- 25 November	The Centre for Islamic Law and Society with the National Centre for Excellence in Islamic Studies hosted the 5th National Islamic Studies Postgraduate Conference. The event was attended by about 50 people. Twenty-four students presented and almost half of the presentations related to Indonesia. Mr Robert Kingham (AusAID's Learning Assistance Program for Islamic Schools or LAPIS, Jakarta), Associate Professor Mike Feener (National University of Singapore), Dr Sally White (ANU), and Dr Minako Sakai (University of NSW) attended as guest mentors.



24 November

The Asian Law Centre and Centre for Islamic Law and Society presented a Research Seminar with a presentation by Dr Minako Sakai on the topic of 'Growing Together in Partnership: Women's Views of the Business Practices of an Islamic Savings and Credit Cooperative'.

30 November - 11 December The Asia Institute coordinated a short course for Lecturers at Institutes of Islamic Studies in Indonesia. Twenty senior and junior academics from a range of different Islamic tertiary institutions from across Indonesia participated in a series of seminars and workshops designed to build their capacity in research and administration.



Aceh Research Training Institute (ARTI)

The Aceh Research Training Institute was established in response to the devastation caused to institutions training young Acehnese by the Indian Ocean tsunami of 26 December 2004. Research funding totaling \$3 million was provided by the Myer Foundation and AusAID for the three-year program, which co-operatively draws upon the expertise of eight Australian and four Indonesian universities. The Asia Institute is proud that its largest ever external research grant already has such a strong international impact, in an area of great need and opportunity.

Already 450 graduates have completed ARTI intensive research training, and the most promising are each proceeding through a program of intensive research supervision resulting in submission of a journal article for publication. Each researcher has three mentors, one local, one national and one international. The international mentors have been drawn from ten universities, seven in Australia plus Harvard, NUS and Michigan. Priority research areas include law and religion, livelihoods, gender, conflict and social recovery, environment and community health. Program travel grants supported 90 Indonesian and international PhD students, and over 120 supervisors and lecturers. A range of new digital research resources have been made available for local researchers, from Dutch and local archives through the Institute's Aceh Research Network. The ARTI initiative will be sustained well beyond its initial three years



through the establishment of an International Centre for Aceh and Indian Ocean Studies and a World Bank funded Center for Peace and Conflict Studies Research. These are co-located within the refurbished Aceh Research Centre, at Universitas Syiah Kuala.

Climate Change, Energy and Justice in East Timor

This project will conduct an analysis of the energy needs of people living in Ainaro, East Timor and a survey of the opportunities available in the region for utilising sustainable generation and transmission infrastructure, including the use of distributed systems. The project will conduct a review of the political and regulatory challenges facing the delivery of energy infrastructure in East Timor and an assessment of how current regulatory frameworks exclude vulnerable and disadvantaged groups. This review will consider how the costs of providing sustainable energy infrastructure and securing universal access to energy ought to be distributed in and between developed and developing countries in the light of an egalitarian response to climate change.

Collaborating partners for this project include Oxford University, McGill and UNESCO. It is being funded through an ARC Fellowship awarded to Dr Jeremy Moss valued at \$604, 760, beginning in 2009 and lasting until 2013.

Aline Scott-Maxwell is Indonesian Studies Library Consultant and is based in the Asia Institute one day per fortnight. Her appointment at the University of Melbourne is part of a co-operative arrangement with Monash University Library, where she is Senior Asian Studies Librarian and Southeast Asian Studies Librarian. This shared position is made possible by the Melbourne-Monash protocol and the Asian Libraries in Melbourne consortium, which promotes resource sharing between University of Melbourne and Monash University libraries and reciprocal access to their Asian collections. Aline Scott-Maxwell provides reference support to Asia Institute and Indonesia Forum Indonesian studies staff and postgraduates and coordinates collection development.

Additional library support for Indonesian studies in 2009 was provided by staff in the Collection Services division, including Mary Ann Gibson and Richard Serle, the Pitt Officer, who assisted to build the Library's Indonesian collection in the area of acquisitions. For the first time, the Library provided a comprehensive information literacy program for the Asia Institute, including the Indonesian program. In semester one, weekly classes were targeted at specific languages or provided instruction in broad-based applications including Endnote. These were followed by lunchtime drop-in sessions for individual consultancies. The drop in sessions continued in semester two.

The Library investigated alternative vendors for Indonesian serials in 2009. This followed the mid-year closure of the National Library of Australia's long term Indonesian Acquisition Program due to budget cuts. Bhratara continued to be the Library's supplier for Indonesian books, providing monthly email lists and descriptions of new books to aid selection. Charles Coppel assisted by circulating the Bhratara lists to academics.

The Library continued to develop its collections of Indonesia-related monographs and other materials. A total of 403 books were acquired, covering Indonesian politics and government, religion, history, anthropology, language, law, education, mass media, architecture and music. Of particular interest was the acquisition of 16 Chinese-language titles written by Chinese-Indonesian authors and published in Indonesia. The majority of titles were purchased from the Library's allocation to the Asia Institute and from the Pitt Bequest, which was established to support the work of the School of Historical Studies.

The Centre for International Child Health is currently collaborating with the World Health Organization and the Department of Paediatrics at Gadjah Mada University (UGM) in Yogyakarta to help produce, translate and implement the World Health Organization (WHO) publication, the 'Pocketbook of Hospital Care for Children' with a training CD developed by CICH and piloted in several other Asia-Pacific countries. This WHO publication has been accepted as the official paediatric standard treatment guidelines for hospitals in Indonesia and is currently being trialed in Yogyakarta, Aceh and other provinces.

The Centre for International Child Health is also working with the Department of Paediatrics at UGM on several research projects that will lead to higher research degrees for their staff, which will support the new Paediatric Research Centre at UGM. These projects include a study of childhood tuberculosis (Rina Triasi, PhD student, through University of Melbourne) and the prevention of hospital acquired infections in Indonesia (Ita Kartika, PhD student). In 2009 a University of Melbourne Advanced Medical Science student, Jocelyn Chan completed an Advanced Medical Science project on maternal immunity to rotavirus in Yogyakarta.



Nossal Institute staff members continue to develop collaborative links with Universitas Gadjah Mada, particularly with the Pusat Manajemen Pelayanan Kesehatan (Centre for Health Service Management) under Professor Laksono Trisnantoro.

PROJECTS/ ACHIEVEMENTS

Aceh Partnerships in Health Facility (APiH), has now reached its second phase. Between 2005 - 2008 Aceh Partnerships in Health strove to improve the health of the people of Nanggroe Aceh Darussalam by supporting local organisations in their health programs and services, and to address gaps and neglected areas in the health sector. As a part of this program the Facility worked to develop long term partnerships with local health organisations, both government and non-government, to build their organisational and technical capacity in areas including; mental health, women's and children's health, adolescent health, disability, HIV/AIDS, organisational development, policy and planning, and health information systems. Assistance for language, computer and management skills development of key personnel was also provided.

APiH was implemented through developing partnerships with local non-government organisations or Provincial/District offices. Work was undertaken to increase their management, financial, technical capacity and expertise, thereby maximising sustainability and local service delivery. APiH identified the needs of local partner organisations, assisted them to develop plans to achieve objectives, and supported the implementation of those plans. APiH also monitored activities, to ensure appropriate technical skills and support was available. The aim is for local partner organisations to become independent and self-sustaining.

The Aceh Partnerships in Health Phase II is a continuation of several components of the APiH, including Adolescent Health and Health Finance.

In 2009, the AIHI continued to build on its strong relationship with YAKITA, which was established during APiH and to pilot a youth friendly health services model in Aceh. AIHI documented this through a case study and hopes to disseminate its findings regionally. The Health Finance Study Phase II was also piloted, tested and refined a model for the calculation with the costs of delivery of primary health care services in three districts of Aceh. AIHI, in conjunction with the Provincial Health Office of Aceh, undertook additional data collection on management and program coordination needs.

PROJECTS/ ACHIEVEMENTS

The Centre for International Mental Health (CIMH) has a strong history of collaborative partnerships with leaders in mental health systems development and services in Indonesia, particularly with UI. Several of the key leaders for mental health systems and policy development in Indonesia are past graduates of a Melbourne-Harvard Mental Health Leadership Program (iMHLP). Following the Indian Ocean Tsunami, CIMH Director, Harry Minas with Dr Benedetto Saraceno of the World Health Organization Geneva, assisted the Indonesian Ministry of Health to develop the Ministry's mental health plan for Aceh. Online website: www.cimh. unimelb.edu.au/education/aceh.

Since 2005 CIMH has been involved in the development of mental health system in Indonesia both at local and national levels, ranging from program implementation, capacity building, and policy development activities. These have included:

1. Indonesia National Task Force on Mental Health Development (2008-2009)

The CIMH was awarded an AusAID Public Sector Linkages Program grant for the project National Taskforce on Mental Health System Development in Indonesia, which commenced in June 2008 and finished at the end of 2009. The aim of the project was to strengthen the capacity of the Ministry of Health to plan, implement, manage and evaluate mental health systems at provincial and district levels and to develop effective and equitable community-focused mental health services. The project established a National Taskforce



on Mental Health System Development. Four Taskforce working groups received training, mentoring and technical support and produced proposals on key mental health system elements: mental health legislation, policy and financing; community mental health workforce; integrated hospital and community-focused mental health services; and ethics, human rights and advocacy. Local solutions found for long-standing problems included development of community-focused mental health services to increase access to services.

The National Taskforce on mental health system development achieved its objectives, which included capacity building for Ministry of Health in planning, implementing, managing and evaluating mental health system in Indonesia; improving mental health policy by producing policy papers as a groundwork to develop the National Mental Health Policy 2009-2013 and a new Health Law that incorporated a chapter on mental health, launched in October 2009. The Taskforce's ability to provide training in leadership for Mental Health System Development in Indonesia was improved through training teachers, developing a full curriculum and training manuals and through improving collaboration and coordination among sectors which deal with mental health issues.

2. International Mental Health Leadership Program (IMHLP)

CIMH has offered the IMHLP program annually since 2001. IMHLP is a global network whose members collaborate on and discuss mental health reform. There are more than 150 graduates of the program in 18 countries, including Indonesia. Since 2002, 30 Indonesian mental health professionals have participated in the IMHLP from a range of institutions, including the Ministry of Health, universities, mental health care services, as well as care and consumer groups. In Indonesia, many IMHLP alumni are demonstrating creative and sustained leadership in developing more effective, equitable and affordable mental health services, as well as protecting and enhancing the human rights of people with mental illness.

3. Study on Mental Health Service Delivery Costing in Primary Health Care in Aceh Indonesia with Public Health Faculty, University of Indonesia (2009-2010)

CIMH has collaborated with the School of Public Health at the University of Indonesia (UI) to conduct a study on mental health service delivery costing in primary health care in Indonesia. The study is funded by the Ministry of Education through an international research collaboration grant. In Indonesia, local health clinics (Puskesmas) are responsible for providing six basic health programs to their communities, but mental health services have not vet been included in their brief. Indonesian District Health research in 2007 clearly demonstrated that mental emotional disorders are guite prevalent in a number of provinces (ranging from 5-20%; with an average of 11.6% all over Indonesia). There are also already some districts, which have been implementing community based mental health programs. However, there is no national standard available to assist with implementation or to provide a reference for calculating the



resources needed to deliver the services to a community. The study aims to develop a model to estimate the costs of providing basic mental health services, based on a Puskesmas in Aceh. This would be of significant benefit for mental health services throughout Indonesia. The study is expected to complete in the first quarter of 2010.

4. Study on the Impact of the Community Mental Health System Strengthening Project in Aceh, Indonesia (2009-2010)

CIMH received an Australian Development Research Award from AusAID in 2009. to support the research and development of a community based mental health program in Aceh. In this research, CIMH is collaborating with the Psychiatry Department at the University of Indonesia (UI). The project will investigate the impact of a community mental health system-strengthening program in Bireuen District, Aceh, Indonesia, and the relationship between mental illness, disability and poverty over a period of 18 months. The project, which has been operating in Bireuen since 2005, aims to strengthen the capacity of the District Health Office to deliver and manage basic mental health services through the primary care system. The population of Bireuen is mostly rural and poor and was greatly affected by long and intense conflict in the province and the 2004 tsunami. This study will investigate the impact of the mental health system strengthening project in Bireuen, its effectiveness in improving the capacity of primary care doctors to recognise and treat mental illness and disability, increasing the capacity of the population of Bireuen to recognise mental

illness and need for treatment, increasing willingness of people with mental illness to seek treatment in the primary health care centre and research the relationship between mental illness, disability and poverty among patients. The study is expected be completed by the end of 2010.

5. Other collaborations and activities

Collaboration with the Psychology Faculty at the Gadjah Mada University (UGM) to establish the Centre for Public Mental Health, the first centre of its kind in Indonesia and possibly in Asia. 

On Sunday 15 March, Melbourne Community Gamelan performed a short wayang fragment at the Immigration Museum as part of a day of Indonesian music, song and dance.

On Sunday 17 May, Melbourne Community Gamelan organised and performed in the Gathering of the Gamelan, with seven other Victorian gamelan groups. This biennial event, which is held at the Consulate General of the Republic of Indonesia, provides an opportunity for the audience to hear a wide variety of gamelan music as well as enabling the groups themselves to hear each other's work and to mix socially. Proceeds from the concert were donated to the Victorian bushfire appeal.

On Monday 14 September, the group presented a multi-media performance, 'Furious Elephants and Small White Mice', as part of the Darebin Music Feast at the Northcote Town Hall. Approximately ninety people attended. The musical pieces all had animal themes and original artwork relating to the themes was prepared by Melbourne-based artists: Michelle Abbott, Michael Ewing, Elizabeth van Herwaarden and Lance Lessels. This artwork was projected on a screen behind the orchestra. Other brackets of music were accompanied by Melbourne-based Abdul (Jayadi) Paembonan, who performed modern, Javanese dance.

On Monday 7 December, Melbourne Community Gamelan, organised and performed in a concert at the Berkeley Street gamelan room to an audience of about 80. This concert, titled 'Indy Music' was in

conjunction with Putra Panji Asmara and a group of musicians playing North Indian-style music – Vinod Prasanna, Glen Kniebeiss and Denis Phelan. Proceeds from the concert were donated to the Red Cross Sumatran earthquake appeal, with about \$300 being raised.

Between 13 August to 1 September, the School of Music (Parkville) and Melbourne Community Gamelan jointly hosted a visit by Dr Joko Susilo, a New Zealand based teacher and performer. Dr Susilo presented a postgraduate seminar to the School of Music (Parkville), repaired instruments, assisted with the preparation for Melbourne Community Gamelan's September performance and led a gadhon (small group) performance at a University of Melbourne reception for international visitors at the Sidney Myer Asia Institute.

Putra Panji Asmara Inc. performs musical pieces from Cirebon, a region on the north coast of West Java, with a focus on music to accompany topeng (masked dance). 
ASIALINK ARTS PROJECTS – ARTS RESIDENCIES

Kate Ben-Tovim is a producer with specialist experience in music-based projects and cross-cultural collaborations. With an academic background in Classical Music Performance and International Relations, she has combined her interest in arts and cultural exchange with projects in Australia, London, China and Papua New Guinea over the last 10 years. In her current role with Arts House, Melbourne, Ben-Tovim has produced two award-winning intercultural music projects that have toured nationally and internationally. She undertook her residency in Yogyakarta at Yayasan Bagong Kussudiardja. During the residency she connected new music and new media artists. In collaboration with Asialink she is currently developing a programming relationship with the Jakarta venue Salihara for the presentation of Australian work in 2010. (Supported by the Australia-Indonesia Institute and the Australia Council)

Cassandra Lehman-Schultz is a multi disciplinary visual artist who creates diverse, expressive work along humanitarian, environmental and activist themes. Her three month residency with Cemeti Art House in Yogyakarta gave her the opportunity to work in situ at the massive landfill site at Piyungan, on the outskirts of Yogyakarta and to collaborate with local artists in exploring waste as a product of colonialism. Where her previous work explored the shifts in value and meaning embodied by objects that serve as vessels of containment and regeneration, Lehman-Schultz's current practice investigates the processes of commodification and exchange that deepen these cultural and economic investments. (Supported by the Australia-Indonesia Institute and Arts QLD).

Anna Loewendahl is a theatre director, animateur and performer. She is Co-director of TransVision Arts, an organisation dedicated to social change through performance. Whilst in Indonesia, Loewendahl directed the puppet street-theatre show Mau Apa? She coordinated workshops on community theatre and also directed two children's shows. Loewendahl has worked with YSpace aerial dance, social theatre in Zimbabwe, and teaches dance to youth at risk. Loewendahl's residency at Papermoon Puppet Theatre signifies a temporary departure from an arts and theatre practice that uses a relatively fixed set of tools and strategies, to an opportunity to engage in Jakarta's unique culture, exchanging creative ideas that challenge her existing theatre-making praxis. (Supported by the Australia-Indonesia Institute and the Australia Council).

Based in Adelaide, Laura Wills works across a wide range of disciplines including painting, installation, media arts, performance and community work. The basis of Wills's practice is a keen interest in ecological and social issues and she uses found materials such as maps to draw on in her work. Wills has worked nationally and internationally in various exhibitions, artist run spaces and on community and collaborative projects. Wills used her residency with Cemeti Art House in Yogyakarta to develop a new body of drawing work on found materials from Indonesia, and continue her research into site specific cross-cultural installation projects. 
ARTS MANAGEMENT

Asialink Arts finalised its 10-year funding program from The Ford Foundation, Jakarta, which has supported Arts Management training for Indonesians in Australia. This has taken the form of internships in Australia and forums in Indonesia, as well as a pilot program of exchanges between Eastern Indonesian and the Northern Territory (the NT/NTT program). A final iteration of the program has been the selection, editing, translation and publication of three Arts Management how-to texts for use in Indonesia. They are on Art Exhibition Touring, Festival and Event Management and Community Cultural Development. Each text has been prepared by Australian colleagues for an Indonesian audience, the texts are in Indonesian and available free from the Kelola Foundation in Jakarta. A formal launch is planned early in 2010.

ASIALINK ASIA EDUCATION FOUNDATION

Australia-Indonesia BRIDGE Project

The Australia-Indonesia BRIDGE (Building Relationships through Intercultural Dialogue and Growing Engagement) Project increases knowledge and understanding between Australia and Indonesia through school-toschool partnerships linking students in both countries through online digital collaboration. The Australia-Indonesia Institute (AII) has partnered the Asia Education Foundation to manage the implementation of the Australia-Indonesia BRIDGE Project (with in-country support from DEEWR and Kang Guru Indonesia). The All has received funds from The Myer Foundation and AusAID to support school engagement through BRIDGE. The project will occur over three years (from 2008-2010) and will involve 184 educators from across Indonesia and Australia from 46 Australian and 47 Indonesian schools. The BRIDGE Project provides Information, Communication and Technology (ICT) training to participating educators, and has developed more than 60 online collaborative activities across a variety of curriculum learning areas, and 45 online school partnership workspaces for class-to-class interaction. BRIDGE builds skills, knowledge and expertise in teachers and students in both countries.

APPENDIX 1:

Indonesia Forum terms of reference

To provide an inter-faculty forum for the sharing of information about Indonesia such as news of current events, visitors, university systems and contacts between the University of Melbourne and universities in Indonesia.

To develop knowledge of how to establish contacts in Indonesia for the purposes of research, inter-university linkages and exchange programs, and marketing education programs at the University of Melbourne.

- To broaden knowledge within the University of existing and potential institutional linkages with Indonesia.
- To increase awareness of such international education agencies as IDP and AEC.
- To host visits by Indonesians to the University of Melbourne.
- To share experiences in cross-cultural communication with Indonesians
- To disperse information on opportunities in relation to Indonesia with the various faculties at the University of Melbourne.
- To make policy recommendations to the International Programs Committee (previously the International Policy Advisory Group).
- These Terms of Reference were originally formulated in 1992 for the Indonesia

Interest Group. After the University's formal recognition of the Country Forums, the Convenors of the existing groups expanded on the Terms of Reference for the Indonesia group to create a new document which includes terms of reference and operational guidelines for all Country Forums. The Terms of Reference for the Country Forums are reproduced below.

APPENDIX 2:

Terms of Reference for Country Forums

The Country Forums have been established to encourage and develop inter-faculty communication between academics, administrative staff, graduate students from the University of Melbourne, and other interested persons who have international teaching, research and other international interests.

In 1996, the Country Forums were granted formal recognition by the University. This is evidence of the University's commitment to internationalisation. There are currently six active Country Forums focusing on China, India, Indonesia, Japan, Thailand and Vietnam.

The Country Forum Convenors' Committee was established as a mechanism for the sharing of information and to facilitate the operation of the Country Forums. The Convenors' Committee recognises that the participation and enthusiasm of the members of each Country Forum is vital to the success of the project.

A Forum

- To provide an inter-faculty forum for the sharing of information about the countries of interest such as news of current events, visitors, university systems and contacts between the University of Melbourne and universities in the country of interest.
- To involve graduate and undergraduate students in the activities of the Country Forum.
- To encourage Departments to involve visiting scholars in the activities of relevant Country Forum(s).

Country Liaisons

- To broaden knowledge within the University of existing and potential institutional linkages with academics, universities and agents in the country of interest.
- To develop and nurture knowledge of how to establish contacts in the country of interest for the purposes of research and inter-university linkages and exchange programs.
- To liaise with the University of Melbourne Alumni Chapters in the specific countries and provide assistance if required on scholarship selection and interaction with the University.



External Relations

- To assist in the dissemination of relevant information regarding the international activities of the University of Melbourne to external country groups, consulates, DFAT, Business Councils and Chambers of Commerce, where appropriate.
- To assist in the promotion of the University of Melbourne within the country of interest.

Visitors

- To liaise with Protocol on visits of Chancellery and diplomatic level visitors.
- To assist in hosting visits by academics and high profile visitors.
- To encourage academics and staff to report on visits to relevant countries of interest.
- To provide a vehicle for monitoring the experience of visiting academics to the University. (Those here for longer than one day.)

Advisory

- To share experiences in cross-cultural communication.
- To make recommendations to the Country Forum Convenors' Committee on mechanisms to improve the international activities and academic programs of the University of Melbourne.
- To act as a resource/reference group for the consideration of University strategies for each country.

Governance/Reporting

- To annually elect Convenors and Vice Convenors.
- To report annually to the Country Forum Convenors' Committee.
